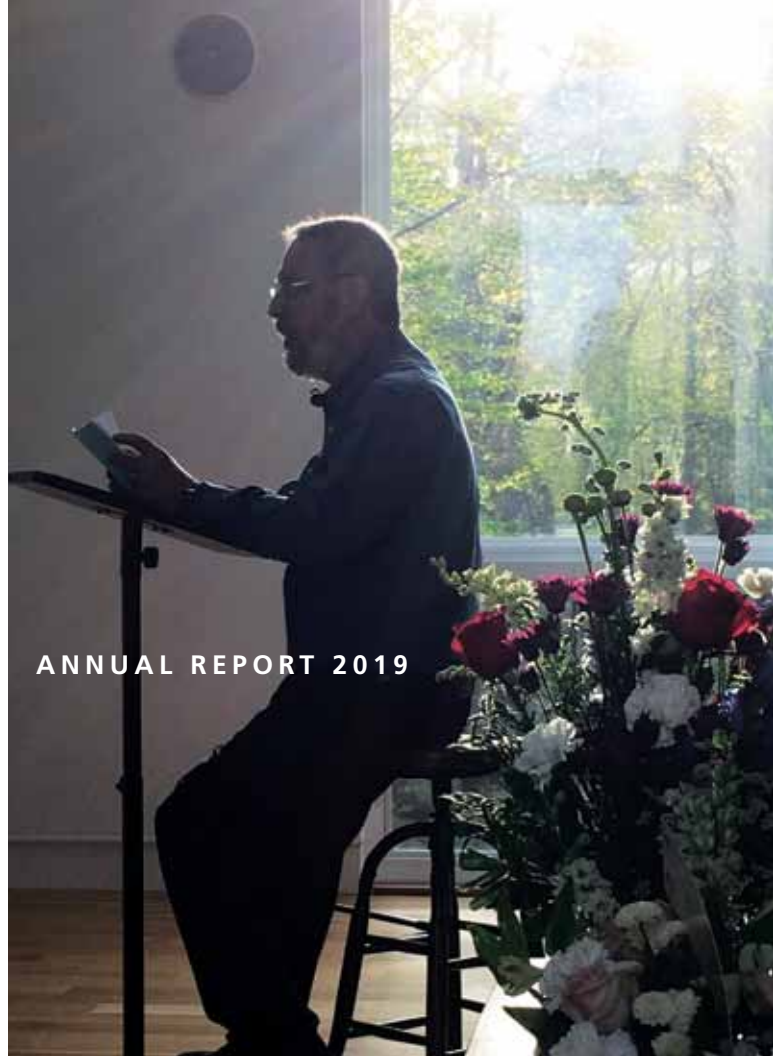

**IN MEMORIAM: WESTPORT HISTORICAL SOCIETY  
PRESIDENT TONY CONNORS 1946-2019**

Our entire community mourns the loss of Historical Society President Tony Connors who died on September 20, 2019.

Tony Connors was President of the Westport Historical Society for over a decade. During his tenure, he steered the WHS through the purchase, restoration and opening of the historic Handy House. His gentle leadership style enabled the Historical Society to flourish and grow.

Of equal note, Tony became the unofficial town historian for Westport—author, educator, lecturer, and spokesman—who created accessible and meaningful perspectives on local history. His public programs, whether lectures, walking tours, or articles, were notable for being entertaining, scholarly, and insightful. He made our local history relevant and significant beyond the boundaries of our town. He will be greatly missed.

**EVENTS AND ACTIVITIES 2019**

Our organization continues to be guided by the strategic plan created in 2018 that consists of four overall goals, each with a set of milestones and a three-year time-frame.

- To define the best use of the Bell School
- To improve collections storage and preservation
- To ensure ongoing relevance to our community
- To build organizational capacity



**BELL SCHOOL**

One of our most enduring challenges is to improve storage conditions for our collection. This year, with the assistance of architect Damon May (Dewing Schmid Kearns Architects), we explored the possibilities offered by the Bell School, such as better use of presently occupied space and potential use of an additional 1000 square feet in the currently unused basement. We are encouraged by the possibilities which will be evaluated by the Board of Directors in the coming months.

Closely tied to the question of storage is the need to revisit the overall vision for the Bell School, a building which has had many lives as a school, a community hall, a library, a museum, and headquarters of a historical society. What is the best use of the building given the current needs of the historical society and the revitalization of the Head of Westport? The Board will craft its vision over the coming months. (Your ideas are most welcome!).

This year we have begun to tackle the significant issue of deferred maintenance which has taken its toll on the Bell School. Thanks to an incredibly generous anonymous donor, we were able to complete repairs to the Bell School's foundation and sill, stabilizing the building for years to come. In addition, we have secured Community Preservation Act funding to restore the bell tower and replace the roof, a project which is scheduled for summer of 2020.

**COLLECTIONS**

We have continued to increase intellectual accessibility to underutilized collections by digitizing the recordings of interviews conducted in 1976 with Community Preservation Act funding.

**PUBLIC ENGAGEMENT**

The Westport Historical Society maintains a robust schedule of annual events, each reaching out to a different sector of our community, and each sustaining the vitality, relevance, and finances of the Society in different ways.

In an effort to broaden our relevance to the community, the historical society introduced several new initiatives. The community scanning day held in April, provided an opportunity to augment our collection digitally. A total of 200 images were scanned during the event

As part of an effort to encourage the Baby Boomer generation to document the 1950s and 1960s, we held a "Then and Now Pop-Up Museum" at the Handy House, featuring an eclectic panoply of objects, from the rotary phone to the record player, that have now become collectors' items.

We were delighted by the response to our first gravestone cleaning training workshop in August, which formed the beginnings of a team of volunteers who will care for Westport's cemeteries.

Throughout the summer and fall, we focused on the Native American heritage of Westport with a series of demonstrations by Elizabeth James-Perry, member of the Wampanoag Tribe of Gay Head, and an exhibition at Handy House. Master gardener and board member, Libby Baylies, created a garden of plants used by Native Americans for food, medicine, dyeing and weaving.

Our monthly winter history forum programs regularly attracted audiences of 100 plus people. Topics included:

- Old Horseneck Beach presented by David Jones
- Land surveying and stone walls presented by Sean Leach
- Gifford Family of Westport presented by Richard Gifford

The Handy House Artisan Fair and Vintage Market drew 800 plus people and our October Halloween event attracted 220 kids and parents.

Our two websites, wpthistory.org and PaulCuffe.org and our Facebook page continue to provide a lively forum for engagement and education.

**EDUCATION**

During fiscal year 2019, the Children's Heritage Education Program interacted with grades K – 3 and grades 7- 8, from Westport Community Schools. We reached a total of 501 students through 24 points of contact. We continued our long term collaboration with the Westport River Watershed Alliance and the Westport Public Library. Our K-2 programming about the Macomber Turnip, Sarah Turner, and Paul Cuffe continued. Steadfast volunteer Sarah Gifford's creative storybook reading continued to inspire a captive Kindergarten audience and very special thanks go to John "JD" Squires, Produce Manager at Lees Market, for his tenacity in procuring fresh Macomber Turnips with greens intact for that program. Thanks also to Robin Winters for her help in teaching the Jr. High School Art Club how to hand sew and to Mary Ries, Sarah Gifford, Colleen Kearney, Marilyn Packard Luther, Nancy Mailhot, and Harbourmasters Chris Leonard and Jonathan Paull for all of their dedicated assistance with school tours. A pilot program to deepen the local history learning experience for 3rd grade was launched over four months, using objects from the collection, maps, and hands-on lessons.

### ORGANIZATIONAL CAPACITY

At our October annual meeting, we welcomed Al Lees back to the Board of Directors and, with gratitude, passed the responsibility of leadership into his hands.

A freshly invigorated Leadership Committee, chaired by Breck Arnzen, has begun the long-term task of identifying potential committee members and board members. This year, our small core of employees was boosted by the addition of a part-time administrative assistant, Joanne Demarco. She arrived fully trained in all tasks, thanks to her years as a volunteer.

### FINANCIAL SUSTAINABILITY

The Historical Society received two significant and unexpected bequests this year: The Elvira Smith bequest of \$197,000 and the Esther Cabral bequest of \$62,000. These gifts have been designated by the Board as long-term assets, providing a sustaining fund for the historical society's future.

Our annual operating budget of \$130,000 continues to be fully funded by a combination of the enormously popular House Tour which raised \$35,000, our annual appeal fund, memberships, grants, and judicious withdrawal of funds from our board designated endowment and the Sylvan Endowment.
