Dear Mr. Hall.

Mr. Karolik has just given me his check, drawn to your order, in the amount of five hundred dollars, in payment of the quilted bed cover you have kindly agreed to sell to him. He has instructed me to ask you for a receipt. I enclose a sample form for your convenience if you wish to use it.

Mr. Karolik has also asked me to obtain all the pertinent information we can gather concerning the maker. design. date and history of the quilt. Notes written on the lower part of the framed document which accompanies the quilt indicate that the quilt was made by a negro woman, Mrs. Harriet Powers (born October 29, 1837) in Athens Georgia, and that it was given to Dr. Charles Cuthbert Hall when he was Chairman of the Board of Trustees of Atlanta University, Georgia. I believe you told me that Dr. Hall was your father, and that because of certain events in his life, you believed the quilt was made, or given to him, between 1895 and 1906. Did you also tell me that Mrs. Powers worked as a servant in your father's home? If you would be good enough to confirm or correct these few notes, and add any supplementary information which might be pertinent, both Mr. Karolik and the Museum will be most grateful.
